### **NIGHT ONE** A FIRM FOUNDATION

On night one, we lay a firm foundation with philosophical, spiritual, and practical training on effective school board service. Amanda Banks, Senior Vice President at Family Policy Alliance Foundation opens with an introduction to the School Board Academy and an overview of statesmanship—what it means and how to apply statesman principles to school board service.

#### **SESSION 1: Worldview Training**

An overview of the significance of worldviews, the Biblical Worldview, and the major worldview issues impacting America. Includes salient applications for public servants and educators. Taught by **Ben Quine**, Vice President of Christians Engaged.

#### **SESSION 2: Parliamentary Procedure**

A mini-course on Robert's Rules of Order and fundamentals of parliamentary procedure applied to school board meetings. Taught by **Dr. Bill Gillmeister**, president of Call to Order.

#### **SESSION 3: Preparing for Success**

A practical discussion on jurisdiction of school boards, how to manage responsibilities, relationships, and best practices for effective school board service. Panelists include school board vice president, **Dawn Lang**; former school board president and interim superintendent, **Aaron Salt**; and former State Board of Education member, **Kendra Wesson**.

### **NIGHT TWO** CURRICULUM MATTERS

On our second night of training, we'll explore the critical—and often controversial—curriculum decisions faced by school boards. Participants will learn from national leaders on the topics of sociopolitical education, age-appropriate standards, sex education, parental rights, and more. Model policies and strategies for success will be offered in each session.
