This includes managing the Family Policy Alliance Knowledge Exchange in the area of public policy and the legislation tracking database service provided to Family Policy Alliance. The Manager, Public Policy also works with Strategy Team members to provide the research and content necessary to carry out the Strategy Team's annual plan of action to advance or oppose legislation at the state, national and local levels.

Qualifications include:

- A mature Christian faith and fully supportive of Family Policy Alliance's Statement of Faith and Foundational Beliefs (see www.familypolicyalliance.com/careers/).
- Bachelor's degree in a pertinent field of study such as political science, journalism, theology, philosophy or government required, while a graduate degree or significant experience in law, public policy, etc., preferred. An attorney is preferred for this role.
- Demonstrated desire to work in a ministry which engages in the American system of government to affect the outcome of public policy, legislation, elections and culture for Christian values and families.
- Participates in the development and execution of integrated policy, communications, messaging, alliance-building, legal, etc. strategies for implementation alliance wide, focusing especially on state FPA's.
- Takes leadership of the Family Policy Alliance Knowledge Exchange in the area of public policy and Family Policy Alliance's legislation tracking database service.
- Understands and applies campaign finance law for the affiliate state organizations. Assists in the gathering of information for, and filing of, necessary reports. This includes tracking affiliate state organization election activities. Understands and applies lobbying compliance laws for the affiliate state organizations. Assists in the filing of necessary reports.
- Conducts and participates in national and local media opportunities such as providing interviews and quotes for the purpose of promoting policy that advances FPA's vision and mission, and increasing brand awareness.
- May be asked to participate and present in conferences that promote alliance-building and legislative relationships.
- Strong relationship building skills, and ability to track relationships and activities in database, to accomplish goals.
- Persuasive and passionate oral and written communication skills, including public speaking and writing experience. Produce weekly email content.
- Able to work in a collaborative, team-centered environment, with limited supervision, while demonstrating a self-starter ability.
- Excellent organizational, planning and time-management skills, as well as flexibility in changing circumstances.
